## 1 | BEFORE THE WASHINGTON STATE **EXECUTIVE ETHICS BOARD** 2 3 In the Matter of: EEB Case No. 2023-071 4 FINAL ORDER Daryl Hamilton-Manier, 5 Respondent 6 7 I. PROCEDURAL HISTORY 8 On August 15, 2023, the Executive Ethics Board (Board) received an agency referral 9 alleging that Daryl Hamilton-Manier, an employee of the Washington State Employment 10 Security Department (ESD), may have violated the Ethics in Public Service Act. The complaint 11 alleged that Daryl Hamilton-Manier violated RCW Chapter 42.52, by using state resources for 12 non-work related activities. 13 The Board entered an Order of Default on March 14, 2025. On March 18, 2025, Board 14 staff provided Daryl Hamilton-Manier with notice of the Board's Order of Default by regular and 15 certified mail. 16 Pursuant to WAC 292-100-060(4) Daryl Hamilton-Manier was allowed 10 days to 17 request vacation of the Order of Default. Daryl Hamilton-Manier has not moved to vacate the 18 order entered on March 14, 2025. 19 II. FINDINGS OF FACT 20 21 1. According to the referral, Daryl Hamilton-Manier allegedly downloaded 238 22 files to an external USB device on May 15, 2023, and June 13, 2023. An ESD internal fraud 23 investigator had noted the large downloads on the system and upon initial review there was 24 potential that the files were personal in nature and potentially also had client information 25 contained within the downloaded files. 26
